Under the [Radiation Protection and Control Regulations 2022 \(legislation.sa.gov.au\)](http://legislation.sa.gov.au), no person is permitted to dispose of a sealed radioactive source without first obtaining the approval of the SA Environment Protection Authority (Regulation 65). Under Regulation 67 an application for approval to dispose of sealed radioactive source must be made by:

- in the case of a registered source –the registered owner of the source; or
- in any other case – the owner of the source.

An application may relate to the disposal of 1 or more sealed radioactive sources. The application must be in writing and:

- specify the source or sources to be disposed of; and
- contain details of the source or sources to be disposed of including their chemical and physical form and the activity of such source or sources; and
- contain details of the place or places where the source or sources will be disposed of; and
- contain the approximate date or dates when the source or sources will be disposed of; and
- contain details of the method of the proposed disposal including details of segregation, labelling, monitoring, and transport; and
- contain details of any container or device in which the source is housed; and
- contain the name of any person or persons who it is proposed will handle the source or sources during the course of their disposal.
