I am always concerned when I hear glass being broken as it is loaded in kerbside collection as it so often devalues other materials such as paper and cardboard. Widening the range of the glass bottle deposit scheme in particular would make a great difference to this problem. I also am very much in favour of increasing the deposit amount to twenty cents as I think it would be much more effective in encouraging people to recycle more appropriately. I strongly believe that there needs to be more consistency in what is accepted for recycling and what is not. Our future depends on it.
