Dear Resident

Re: Proposed groundwater prohibition area in portions of Beverley, Woodville, Woodville South, Woodville West, Woodville Park, West Croydon, Kilkenny, Findon and Seaton

The Environment Protection Authority (EPA) is writing to you as a resident of Beverley and surrounding suburbs to advise that it proposes to establish a groundwater prohibition area.

Groundwater in this area is contaminated from past industrial activities and will remain so for the foreseeable future. Depending on where you live or work, you may have already been advised not to use your groundwater (bore water) for any purpose.

Where groundwater is affected or threatened by site contamination and action is necessary to prevent actual or potential harm to human health or safety as a result of the taking of that water, the EPA has the ability under the *Environment Protection Act 1993* to establish a groundwater prohibition area. Eight groundwater prohibition areas have been established in South Australia to date.

The EPA is now proposing to prohibit the taking of groundwater from the three upper Quaternary aquifers 0–45 metres below ground in the area indicated in the enclosed fact sheet. Before doing so, we would like to hear from residents and bore users during a 90-day consultation period.
